

Downtown Fond du Lac Partnership Shop Saturday & Win

Official Rules and Regulations

NO PURCHASE NECESSARY. (A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.)
OPEN TO RESIDENTS OF WISCONSIN, AGE 18 AND OVER.

ELIGIBILITY: You must be eighteen or over to enter and win, and a legal resident currently living in Wisconsin. Employees and their immediate families of DFP are not eligible. Only one prize will be awarded. By entering, entrants agree to be bound by these Official Rules, and agree to release the Sponsors and Administrators from any and all liability for injuries, losses or damages of any kind resulting from participation in this drawing.

TIMING: All entries must be received between 12:00 a.m. CST on August 1, 2022 and 11:59 p.m. CST on October 29, 2022 to be eligible to win a prize.

ENTRY: There are two ways to enter: (a) by submitting receipts from your purchases in Downtown Fond du Lac or (b) by mailing in an entry form.

a) Submitting Receipts from your purchases in Downtown Fond du Lac

During the entry period, submit receipts or copies of receipts for purchases made at businesses within the Downtown Fond du Lac District with one form. For each \$10 spent on purchases in downtown businesses, you will receive one entry into the sweepstakes. Entries may be mailed or delivered directly to the Downtown Fond du Lac Wisconsin, 131 S. Main St., Suite 101, Fond du Lac, WI 54935. Qualifying receipts must have a timestamp from 6:00 a.m.-1:00 p.m. on qualifying Saturday's between August 1, 2022 – October 29, 2022. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified. Purchases made outside of the Downtown Business Improvement District map (indicated here) will not be considered.

b) Free mail-in method

To enter this Sweepstakes without making a purchase, hand print your full name, street address (no P.O. Boxes), day/evening/cellular phone number (if any), email address, and date of birth on a 3" x 5" piece of paper and mail it in an envelope with proper postage to "Downtown Fond du Lac Shop Saturday – Mail-In Entry," 131 S. Main St., Suite 101, Fond du Lac, WI 54935. You will receive 1 entry into the Sweepstakes drawing. Limit: 1 entry per stamped envelope.
