BUSINESS NOTES

- Wonder Play Café, located at 15 N. Main Street, held their official Grand Opening Saturday, January 6, 2024. Special shout out to the many downtown businesses and organizations who contributed to their grand opening week through donations, gifts, and words of welcome.
 - Owned by Tristin Holzmann and Katie Oestreich, the café features a great play area for the kids, an espresso bar for the adults, and a great sandwich and sweets menu for all. The DFP supported the opening of this new downtown Fond du Lac business with an Experience Generator Grant.
- **Studio B**, located at 59 N. Main St., opened its doors on January 1, 2024. Staffed by owners Jessica Winkler and Jenna Scott-Streeter, Studio B is the newest downtown Fond du Lac salon to check out for your new 'do.
- Lavish Coffee, located at 21 N. Portland St., is officially open and is already becoming a well-loved downtown Fond du Lac coffee stop. Selections include baked goods from Thunderbird and 3 Sweets Bakeries, gourmet coffee and espresso from Sweet Bloom Coffee Roasters and a new food menu set to launch later this month.
- Bagelmeister, located at 110 S Main St., which closed briefly last month, has changed ownership and re-opened. New owners, Paul and Stacey Gellings, announce their ownership on social media on January 10, and have already begun serving customers with open hours Thursday Saturday each week. The bagel shop serves homemade bagels, sandwiches, sweet treats, specialty coffee and more. Hours are expected to be expanded in March.

2023 DOWNTOWN FOND DU LAC BUSINESS AWARDS

- Nominations for Downtown Legacy and New Business Awards are now open and being accepted through January 31.
- Downtown Fond du Lac Business awards are presented annually to a New Downtown Business (opened within the last calendar year) and a Downtown Legacy Business (opened in downtown for 50+ years) that has shown strength in innovation, resiliency, business performance, and overall contributions to the industry as well as the Fond du Lac community.
- Businesses eligible for the 2023 New Business award must have opened within the Downtown Fond du Lac District during the 2023 calendar year, and remained open through the end of the 2023 calendar year.
- Businesses eligible for the 2023 Legacy Business award must have opened within the Downtown
 Fond du Lac District in 1973 or before, remained open through the end of the 2023 calendar year, and
 must not have been a previous recipient of the Legacy award within the last five years.
- Award winners are selected by committee based upon feedback from the Fond du Lac community by
 way of nomination form submissions. All nominations will be considered with a focus on content
 rather than the quantity received for a particular business.
- Anyone may nominate a business for either category. Self-nominations are encouraged. Please be prepared to share why you believe the downtown business should receive the award.

2024 GRANT PROGRAMS

- Experience Generator Grant Designed to attract businesses who contribute to the overall downtown experience by increasing the vibrancy and vitality of the downtown district, the 2023 Experience Generator Grant Program provides new downtown businesses with funding associated with business startup costs. Eligible business types include restaurants, retail shops, or experience-based businesses such as indoor archery, museums, ceramic art studios, golf simulators, etc. This program provides a \$5,000 grant to assist with business startup expenses.
- New Business Grant Designed to incentivize and assist entrepreneurs with expenses associated with starting a new or expanding business, this program provides a \$2,500 grant to eligible businesses to be used towards startup expenses.
- Creative Sign Grant Designed to incentivize property owners to add to the uniqueness and character
 of Downtown Fond du Lac by undertaking creative projecting sign projects. This program grants up to
 75% reimbursement of the cost to design, manufacture, and install a unique, handcrafted projecting
 sign.
- **Building Improvement Grant (BIG)** Designed to increase property values and support better utilization of properties within downtown Fond du Lac, this grant program incentivizes and assists property owners in making exterior property improvements. The grant reimburses up to 50% of the cost of exterior remodeling expenses.
- Security Grant Program Developed to assist property/business owners with purchasing an exterior surveillance camera system (in partnership with the Fond du Lac Police Department) and/or a rapid entry system lock box (in partnership with the Fond du Lac Fire Department). The program reimburses up to \$250 per exterior camera, and 50% of the cost of each lockbox.

STREETSCAPE DESIGN NOTES

WINTER PARKING RESTRICTIONS

• Effective November 15th – March 15th, the City of Fond du Lac's winter parking restrictions will be in effect. During these dates, all vehicles parked on city streets between the hours of 8 p.m. to 8 a.m. are required to park on the street that corresponds with the date at 8 p.m. On even numbered days, parking is restricted to the even side of the street only, and vice versa. Additionally, any metered area is restricted to 60 minutes between the hours of 2 a.m. and 6 a.m. For complete Fond du Lac winter parking restrictions can be found on the <u>City of Fond du Lac website</u>.

SNOW REMOVAL

- On Wednesday, January 17, the City of Fond du Lac will be removing snow from downtown streets in the early morning hours. Please be sure to notify downtown residents to park in city public parking lots on Tuesday evening.
- The owner, occupant or person in charge of each lot or partial lot fronting or abutting on a sidewalk is required to remove all ice and snow within 24 hours after the cessation of each snowfall. This includes crosswalks and handicapped accessibility ramps if said property is a corner lot. View the complete city ordinance here: Snow Removal Ordinance
- Please note any storm water grates that are adjacent to your property. When shoveling, please keep these areas clear of snow and ice for proper drainage.
- When shoveling, please do your best to create customer pass-throughs on snowbanks.
